## AMENDMENT TO THE BYLAWS OF TUSCANY AT THE VINEYARDS CONDOMINIUM ASSOCIATION, INC.

The Bylaws of Tuscany at the Vineyards Condominium Association, Inc., shall be amended as shown below:

Note: New language is underlined; language being deleted is shown in struck through type.

Article II, Section 6. of the Bylaws of Tuscany at the Vineyards Condominium Association, Inc., shall be amended as shown below:

Section 6. Quorum - A quorum at members meetings shall be attained by the presence of members representing at least thirty percent (30%) of the votes of the entire membership. For Tuscany, the minimum quorum is thirty-six (36) members. Persons entitled to at least a majority of the voting interests shall constitute a quorum but Mmembers present at any meeting, although less than a quorum, may adjourn the meeting to a future date.
